#### Bylaw and membership Update

#### **New Business**

  and items will be -purchased as needed. Expenditures will be reported monthly to

  - SAC members will call 311 re: concerns on Path maintenance (now and in the winter)
  - Parking after school around the school site continues to be a safety concern for staff and families.
  - Tom Cleary will invite HRM Counsellor John Young to attend our next SAC meeting to discuss these concerns.
- 4. Parent concerns about Communication about Combined Classes
  - It has been reported that many parents are concerned about combined classes – how they work, how curriculum is delivered etc....
